MEMORANDUM DECISION AND ORDER (I) GRANTING THE FOREIGN REPRESENTATIVE'S MOTION SEEKING LIMITED RELIEF FROM ORDER STAYING REDEEMER ACTIONS AND ENTRY OF AN ORDER DIRECTING DEFENDANTS TO MAKE EXPEDITED INITIAL DISCLOSURES ON BENEFICIAL HOLDERS AND (II) AUTHORIZING AMENDMENTS TO COMPLAINTS IN REDEEMER ACTIONS

Before the Court is the motion (the "Motion") of Kenneth Krys (the "Foreign Representative" or "Movant"), foreign representative of the Chapter 15 proceedings of Fairfield Sentry Limited, Sigma Limited, and Lambda Limited (collectively, the "Funds"), seeking limited relief from the Court-imposed stay in these Redeemer Actions, pursuant to, *inter alia*, Federal Rule of Civil Procedure ("Rule") 26, so that the Court can enter an order directing defendants (the "Defendants") to disclose any person or entity (the "Beneficial Holders") on whose account

or for whose benefit such Defendants subscribed for or held shares of the Funds that were redeemed in connection with redemption payments at issue in the Redeemer Actions (the "Beneficial Holder Information"). In addition, the Foreign Representative requests permission to file the proposed amended complaints (the "Proposed Amended Complaints") submitted to this Court on November 29, 2011 in order to name and serve additional Defendants identified in those complaints, including Beneficial Holders, and to file additional amended complaints (the "Additional Amended Complaints") so as to name and serve Beneficial Holders identified through the limited discovery sought in the instant Motion.

The Foreign Representative seeks this relief because certain Defendants have indicated that they intend to raise defenses on the grounds that they have acted solely as agents, trustees, or custodians for Beneficial Holders, or that they changed their positions by transmitting redemption payments to Beneficial Holders. The Foreign Representative accordingly seeks expedited disclosure to ascertain the existence and identity of all Beneficial Holders prior to July 22, 2012, the applicable deadline for asserting claims under section 108 of the Bankruptcy Code (the "Code").

This is a document case in which the Defendants signed subscription agreements specifically consenting to the disclosures the Foreign Representative currently seeks. Yet, the Defendants failed to mention this fact in any of the approximately 120 joinders and objections they filed. Instead, they ineffectually argue that the Court must first decide certain threshold issues before granting discovery and that foreign secrecy and data protection laws prevent the disclosure of the names of the Beneficial Holders. But given that the Foreign Representative seeks discovery to which he asserts the Defendants explicitly consented and such discovery is warranted under Rule 26, the Court finds that the Foreign Representative is entitled to the

narrowly-tailored relief he seeks. Accordingly, the Motion is GRANTED to the extent described herein.

DISCUSSION

1. Discovery Is Warranted Under Rule 26 of the Code.

Rule 26(d) of the Code provides that a party may seek discovery before a Rule 26(f) conference "when authorized . . . by court order." FED. R. CIV. P. 26(d)(1). Courts apply a flexible reasonableness standard in determining whether to grant a request for early expedited discovery. Ayyash v. Bank Al-Madina, 233 F.R.D. 325, 326-27 (S.D.N.Y. 2005); see Digital Sin, Inc. v. Does 1-176, No. 12-CV-00126, 2012 WL 263491, at *2 (S.D.N.Y. Jan. 30, 2012); Standard Inv. Chartered, Inc. v. Nat'l Ass'n of Sec. Dealers, Inc., No. 07-CV-2014 (SWK), 2007 WL 1121734, at *5 (S.D.N.Y. Apr. 11, 2007). Courts consistently grant requests for disclosures of the identities and addresses of unknown defendants where, to do otherwise, "the Defendants cannot be identified or served and the litigation cannot proceed." Digital Sin, 2012 WL 263491, at *2; see also 20/20 Fin. Consulting, Inc. v. Does 1-5, No. 10-CV-01006-CMA-KMT, 2010 WL 1904530, at *1 (D. Colo. May 10, 2010) ("Because it appears likely that Plaintiff will continue to be thwarted in its attempts to identify Defendants without the benefit of formal discovery mechanisms, the court finds that Plaintiff should be permitted to conduct expedited discovery, pursuant to Fed. R. Civ. P. 45, for the limited purpose of discovering the identities of Defendants."); see also Alston v. Parker, 363 F.3d 229, 233 n.6 (3d Cir. 2004) (quoting Gillespie v. Civiletti, 629 F.2d 637, 642 (9th Cir. 1980) ("[T]he plaintiff should be given an opportunity through discovery to identify the unknown Defendants").

Applying this reasonableness standard to the instant Motion, the Foreign Representative is entitled to the Beneficial Holder Information at this time. He has no other means of obtaining

this information and absent production by the Defendants, the litigation against the Beneficial Holders cannot proceed. *See, e.g., Digital Sin,* 2012 WL 263491, at *2; Order Directing Certain Defendants to Provide Limited Rule 26(a)(1) Initial Disclosures on an Expedited Basis, *Enron Corp. v. J.P. Morgan Sec., Inc. (In re Enron Corp.)*, Adv. Pro. No. 03-92677 (Bankr. S.D.N.Y. Nov 18, 2003) [Dkt. No. 25] [hereinafter the "Enron Order"] (granting limited discovery to identify parties prior to a Rule 26(f) conference where the named Defendants claimed to have acted solely as agents and the statute of limitations was close to expiring); *see also* Transcript of Initial Pretrial Conferences at 68-69, *Weisfelner v. Morgan Stanley & Co. (In re Lyondell)*, Adv. Pro. No. 10-04609-REG (Bankr. S.D.N.Y. Mar. 8, 2011) [Dkt. No. 145].

2. Threshold Issues Need Not Be Adjudicated First.

Notwithstanding that the requested discovery is warranted under Rule 26 of the Code, the Defendants advance several arguments, none of which are persuasive. The Defendants claim certain threshold issues, such as jurisdiction, service of process, and *forum non conveniens*, must be decided before any discovery can be taken. All the cases cited by the Defendants in support of this proposition, however, are irrelevant because they hold that these threshold issues must be determined prior to a ruling *on the merits. See, e.g., Sinochem Int'l Co. v. Malay. Int'l Shipping Corp.*, 549 U.S. 422, 430-431 (2007) (explaining that "a federal court generally may not rule on the merits of a case without first determining that it has jurisdiction"); *Antwi v. United States*, 349 F. Supp. 2d 663, 669 (S.D.N.Y. 2004) ("[C]ourts must resolve threshold questions of jurisdiction and standing before proceeding to consider the merits of a claim"). The Court is not ruling on the merits at this time and the Foreign Representative does not seek merit-based discovery; he seeks only to identify parties against whom "John Doe" claims are already asserted. As such, the Court need not address the issues raised by the Defendants at this early

stage of the proceedings. *See* Enron Order (allowing expedited discovery to name unidentified defendants where plaintiff moved for that discovery the same day the complaint was filed, before any such threshold issues could be addressed). The Defendants suggest that *111 Debt Acquisition LLC v. Six Ventures Ltd.* dictates otherwise. *See* No. 08-CIV-768, 2008 WL 3874630 (S.D. Ohio Aug. 15, 2008). But they are mistaken because there the court was "not inclined" to allow expedited discovery while jurisdiction was still at issue in part because even in the absence of that discovery the "maintenance of the status quo [was] sustainable." *See id.* at *2. By contrast, here, denying the Foreign Representative's request is mutually exclusive from maintaining the status quo, as such a denial may result in the expiration of the statute of limitations, thus foreclosing the Foreign Representative's suits against the unnamed Beneficial Holders.

3. Defendants' Foreign Secrecy Law-Related Arguments are Unavailing.

The Defendants argue that their respective countries' secrecy and data protection laws (the "Foreign Secrecy Laws") prohibit them from disclosing the names of customers. In reality, this argument is a thinly-veiled attempt to undo Defendants' self-created dilemma arising from their consenting to provide the information the Foreign Representative seeks. In particular, to purchase shares in the Funds, the overwhelming majority of the Defendants executed subscription agreements (the "Subscription Agreements"), which included the amount as well as the terms, conditions, and covenants of their investment. The Subscription Agreements contained a disclosure consent provision (the "Disclosure Consent Provision"):

Subscriber represents, warrants, and covenents that . . . to the extent Subscriber has any beneficial owners or is acting as agent or nominee in connection with this investment . . . it will hold evidence of such identities [of Beneficial Holders] . . . and make available such information and any additional information requested by the Fund that is required under applicable regulations.

Declaration of Shoshana Kaiser In Support of the Foreign Representative's Reply Memorandum of Law (Dkt. No. 747) [hereinafter the "Kaiser Decl."] Ex. A, [Tab 45] ¶ 21(B). The Subscription Agreements also provided for the consent of the Beneficial Shareholders (the "Beneficial Shareholders' Consent Provision" and, together with the Disclosure Consent Provision, the "Consent Provisions"):

If Subscriber is subscribing as trustee, agent, representative or nominee for another person (the "Beneficial Shareholder"), Subscriber agrees that the representatives and agreements herein are made by Subscriber with respect to itself and the Beneficial Shareholder. Subscriber has all requisite authority from the Beneficial Shareholder to execute and perform the obligations hereunder.

Id. at ¶ 28 (emphasis added). For subsequent purchases of shares, shareholders were permitted to sign short form subscription agreements (the "Short Form Subscription Agreements"), which incorporated, *inter alia*, the Consent Provisions. *See* Kaiser Decl. [Tab 547] (specifying that "[underlying shareholders] . . . reaffirm[] each and every representation and covenant made by the undersigned in the original Subscription Agreement").

The Defendants are sophisticated entities with knowledgeable representation. They explicitly agreed to disclose the Beneficial Holder Information by signing the Subscription Agreements or Short Form Subscription Agreements, despite this purported prohibition against such disclosure arising from the Foreign Secrecy Laws. Furthermore, the rights arising under these Foreign Secrecy laws are waivable, *see, e.g.*, Declaration of Luc Thevenoz (Dkt. No. 645) Ex. 10, ¶ 28 ("Except with the consent of the customer . . . any disclosure of customer related confidential information would be a breach of a [Swiss] bank's duty of confidentiality"); Declaration of Andre Prum (Dkt. No. 645) Ex. 14, ¶ 32 (noting consent exception to relevant Luxembourgian bank secrecy laws), and Defendants have purported to obtain these waivers, *see* Kaiser Decl. Ex. A. [Tab 45], ¶ 28 ("Subscriber has all requisite authority from the Beneficial

Shareholder to execute and perform the obligations hereunder."). Therefore, each defendant either (i) obtained waivers from its customers, in which case the Foreign Secrecy Laws do not prevent the disclosure the Foreign Representative seeks, or (ii) failed to obtain such waivers, in which case it cannot now invoke the Foreign Secrecy Laws to prevent the very disclosure to which it specifically consented while aware of such laws. *See Minpeco, S.A. v. Conticommodity Servs., Inc.*, 116 F.R.D. 517, 525 (S.D.N.Y. 1987) (noting bank required by United States law to disclose protected privacy information should have sought waivers of relevant foreign secrecy rights from customers). Thus, the Foreign Representative is entitled to the production of the Beneficial Holder Information.

At the hearing on the Motion held on June 26, 2012, the Movant recognized and conceded that unique circumstances may bring a minority of Defendants (identified at the hearing) outside the purview of this Court's narrow ruling (the "Unique Circumstance Defendants"). Such Defendants are directed to meet and confer with the Foreign Representative to address these individualized concerns within ten days of entry of this Order.

4. The Foreign Representative is Entitled to Amend the Complaints

The Defendants argue that the Foreign Representative's request is procedurally improper because he failed to move under Rule 15 of the Code ("Rule 15"). But a formal motion under Rule 15 for leave to amend is not required so long as the Foreign Representative has clearly put the Court on notice of his intentions to amend the complaints. *See McLaughlin v. Anderson*, 962 F.2d 187, 195 (2d Cir. 1992) (stating that "lack of a formal motion is not [a] sufficient ground for a district court's dismissal without leave to amend so long as the plaintiff has made its willingness to amend clear") (internal citation omitted); *see also O'Hara v. Weeks Marine, Inc.*, 294 F.3d 55, 68 n.6 (2d Cir. 2002) ("[Plaintiff's] failure to make a formal motion [for leave to

amend] is not dispositive.") (internal citation omitted). Here, the Foreign Representative filed the Proposed Amendments Complaints with the Court on November 29, 2011—nearly seven months ago—and the Court and Defendants have long been on notice of the Foreign Representative's intention to amend the complaints. In addition, the instant motion explicitly requests leave to file both the Proposed Amended Complaints and the Additional Amended Complaints. As lack of a formal motion under Rule 15 is not fatal, and the Foreign Representative has clearly put the Court and the Defendants on notice of his intentions to amend the complaints, the Foreign Representative's request for leave to amend the Proposed Amended Complaints and the Additional Amended Complaints is granted.

Conclusion

Accordingly, the Foreign Representative's Motion is hereby GRANTED to the extent described herein. Specifically, (i) Defendants are directed to make expedited initial disclosures of the Beneficial Holder Information within 10 days of entry of this Order; (ii) the Foreign Representative is granted leave to file the Proposed Amended Complaints and the Additional Amended Complaints; and (iii) the Unique Circumstance Defendants are directed to meet and confer with the Foreign Representative to address their individualized concerns within 10 days of entry of this Order. Sanctions for noncompliance with this Order will be determined if and when appropriate.

IT IS SO ORDERED.
