**CERTIFICATE OF NO OBJECTION TO MOTION FOR ENTRY OF AN ORDER

2002 AND 9019 OF THE FEDERAL RULES OF BANKRUPTCY PROCEDURE  
APPROVING A SETTLEMENT BY AND BETWEEN THE TRUSTEE AND  
DEFENDANT RUTH MADOFF**

Irving H. Picard, trustee (“Trustee”) for the substantively consolidated liquidation of the business of Bernard L. Madoff Investment Securities LLC under the Securities Investor Protection Act, 15 U.S.C. §§ 78aaa–III, and the estate of Bernard L. Madoff, by and through his undersigned counsel, submits this certificate pursuant to Local Bankruptcy Rule 9075-2, and respectfully represents:

1. On May 3, 2019, the Trustee filed the Motion for Entry of an Order Pursuant to Section 105(a) of the Bankruptcy Code and Rules 2002 and 9019 of the Federal Rules of Bankruptcy Procedure Approving a Settlement By and Between the Trustee and Defendant Ruth Madoff (the “Motion”) (ECF No. 52), and caused the Motion to be served on the same date.

2. The deadline for filing objections to the Motion expired on May 22, 2019.

3. Notice of the Motion was timely provided by U.S. Mail, postage prepaid or email to (i) defendants in the adversary proceedings; (ii) all parties included in the Master Service List as defined in the Order Establishing Notice Procedures (ECF No. 4560) (the “Notice Procedures Order”); (iii) all parties that have filed a notice of appearance in this case; (iv) the Securities Investor Protection Corporation, pursuant to the Notice Procedures Order; and (v) all parties set forth on Schedule A attached to the Affidavit of Service for the Motion, which was filed with the Court on May 3, 2019 (ECF Docket No. 53).

4. Counsel for the Trustee reviewed the Court’s docket not less than 48 hours after expiration of the time to file an objection, and to date, no objection, responsive pleading, or request for a hearing with respect to the Motion, appears thereon. Additionally, no party has indicated to the Trustee that it intends to oppose the relief requested in the Motion.

5. An electronic copy of the proposed order (the “Order”), that is substantially in the form of the proposed order that was annexed to the Motion will be submitted to the Court along with this certificate.

6. Pursuant to Local Bankruptcy Rule 9075-2, the Trustee respectfully requests that the Order be entered without a hearing.
