1. The Defendants shall respond in writing to document requests (Nos. 8, 9, 10, 23, 25, 31,

33, 34, and 36) to the Trustee by no later than December 15, 2025.

2. The Defendants shall produce documents responsive to each such document request or

certify in writing to the Trustee that the Trustee already has access to the requested documents and

identify the responsive documents previously produced to the Trustee and in what prior court

proceeding such responsive documents were produced to the Trustee or certify in writing to the

Trustee that there are no responsive documents to produce.

3. Should Trustee's counsel acquire a transcript of the September 30, 2025 Conference,

Trustee's counsel is required to provide the transcript to the Defendants.

4. This Court retains jurisdiction with respect to the implementation and enforcement of this

Order.
