"Conference") regarding a discovery dispute with defendants Union Securities Investment Trust

Co., Ltd., Union USD Global Arbitrage Fund, Union USD Global Arbitrage A Fund, and Union

Arbitrage Strategy Fund (the "Defendants");

WHEREAS, on October 16, 2025, the Defendants submitted a letter in response to the

Trustee's October 13, 2025 letter (ECF No. 129);

WHEREAS, on October 21, 2025, the Conference was held before the Court.

NOW, THEREFORE, IT IS HEREBY ORDERED:

1. The Defendants shall respond to Requests 1-8 of the Trustee's Second Set of

Requests for Production of Documents, dated July 31, 2025 (ECF No. 125, at Ex. 3), within

thirty (30) days of entry of this Order; provided that, the "Applicable Period" for Requests 1-8 of

the Trustee's Second Set of Requests for Production of Documents shall be limited to January 1,

2006 – January 31, 2016; and

2. The Defendants shall designate a witness or witnesses to testify regarding all

agreed upon topics contained in the Trustee's Rule 30(b)(6) Deposition Notices to Defendants,

dated August 20, 2025 (ECF No. 125, at Ex. 5), including Topics 1-8; provided that the

"Applicable Period" for Topics 1–8 of the Trustee's Rule 30(b)(6) Deposition Notices to

Defendants shall be limited to January 1, 2006 – January 31, 2016, except as otherwise agreed to

by the Trustee and the Defendants prior to such Rule 30(b)(6) Depositions.
