STIPULATION AND ORDER TO ADJOURN DEADLINES *SINE DIE*

Plaintiff Irving H. Picard, as trustee (the “Trustee”) for the substantively consolidated liquidation of Bernard L. Madoff Investment Securities LLC under the Securities Investor Protection Act, 15 U.S.C. §§ 78aaa–III, and the chapter 7 estate of Bernard L. Madoff, and defendants OFI MGA Alpha Palmares (f/k/a Oval Alpha Palmares), Oval Palmares Europlus, and UMR Select Alternatif (collectively, the “OFI Defendants” and, together with the Trustee, the

“Parties”), by and through their respective undersigned counsel, hereby stipulate and agree as follows:

WHEREAS, on May 12, 2025, the Parties entered into an Amended Case Management Plan setting forth various discovery deadlines, including a fact discovery cut-off date of December 31, 2025 (ECF No. 226); and

WHEREAS, the Parties have reached a settlement in principle and agreed to request that all pending deadlines be adjourned *sine die* to allow the Parties to complete the settlement.

NOW, THEREFORE, IT IS HEREBY STIPULATED AND AGREED, by and between the undersigned counsel, and upon review by the Court it is **ORDERED**, as follows:

1. All pending deadlines are adjourned *sine die*.
