**ORDER SCHEDULING HEARING ON AND ESTABLISHING A BRIEFING
SCHEDULE FOR THE TRUSTEE'S MOTION TO COMPEL DISCOVERY**

WHEREAS, on April 27, 2026, Irving H. Picard as trustee (the "Trustee") for the substantively consolidated liquidation of Bernard L. Madoff Investment Securities LLC, under the Securities Investor Protection Act, 15 U.S.C. §§ 78aaa-III, and the chapter 7 estate of Bernard L. Madoff in the above-captioned adversary proceeding filed a letter requesting a discovery

conference to resolve issues relating to the defendant Korea Exchange Bank's ("KEB") disclosure of the identities of its employees in connection with the Trustee's discovery requests [ECF No. 163]; and

WHEREAS, on April 28, 2026, KEB filed a letter in opposition to the Trustee's request for a pre-motion conference in advance of a motion to compel [ECF No. 165]; and

WHEREAS, on May 4, 2026, KEB filed a supplementary letter and declaration in opposition to the Trustee's request for a pre-motion conference [ECF No. 168]; and

WHEREAS, on May 5, 2026, the Court held a discovery conference (the "Discovery Conference"); and

WHEREAS, for the reasons stated on the record at the Discovery Conference, the Court set forth a schedule for briefing and hearing on the Trustee's forthcoming motion to compel discovery (the "Motion").

NOW THEREFORE, it is ORDERED that:

1. The deadline for the Trustee to file and serve its Motion is **May 15, 2026**.
2. The deadline for KEB to file and serve its opposition to the Motion is **June 5, 2026**.
3. The deadline for the Trustee to file and serve its reply is **June 12, 2026**.
4. The hearing on the Motion shall take place on **June 23, 2026 at 10:00 a.m. (ET)** via Zoom for Government.
5. This Court retains jurisdiction over all matters related to or arising out of the implementation and enforcement of this Order.
