Picard of Disinterestedness of Trustee and the Declaration of David J. Sheehan of Baker & Hostetler LLP; having received no objections from any party in interest to the retention in office of the Trustee or Baker & Hostetler LLP on the grounds that such persons are not disinterested; and good cause appearing therefor, it is hereby

ORDERED, DECREED, AND ADJUDGED that the Trustee and Baker & Hostetler LLP are disinterested pursuant to the provisions of Section 78eee(b)(6) of SIPA, Bankruptcy Code Section 327(a) and Federal Rule of Bankruptcy Procedure 2014(a).
