the nominees for the Sentry A are as follows:

10,746,76 shares UBS/Zurich-Switzerland
4,588.64 shares Clearstream Banking/Luxembourg
1,468.14 shares DEXIA BIL/Luxembourg

The nominees for the Sentry B are as follows:

949,74 shares DEXIA BIL/Luxembourg

For all further investments in the Sentry B (which is the only Sentry new investments are possible) the nominee will be Dresdner Bank Lateinamerika/Dresdner Bank.
We also intend to change the bookentry for all the other already bought shares to Dresdner Bank Lateinamerika/Dresdner Bank as we now settle directly with Fairfield. This should make everything a little easier for the future.

The purchases for the Sentry B are as follows:

949,74 shares purchased on August 27th., 2003 There was another investment in the Sentry B of USD 2,665,000 made on October 29th., 2003 (nominee Dresdner Bank Lateinamerika/Dresdner Bank.
Currently we do have USD 980,000 (already approved by Fairfield) for the next deadline which is supposed to be en of November 2003.
